**Prof. Didier Georgakakis,**  
Jean Monnet Chair,  
Université Paris 1 Panthéon-Sorbonne

**Didier Georgakakis** has been a visiting professor at Bruges for the last 10 years and has been a professor of political science at Université Paris 1 Panthéon-Sorbonne since 2012, where he holds a Jean Monnet Chair. He also chairs the Sorbonne master's degree in European public affairs and the joint ENA/Paris 1 master's degree on policies in Europe. He was previously a professor at Sciences Po Strasbourg (1997-2012) and a junior member of the Institut Universitaire de France (2007-2012). As one of the founders of the field of historical and political sociology of the EU, his teaching and research look at the professionals behind EU policies and governance, broader transdisciplinary perspectives on European integration and transnational social fields. He is a Vice-president of the Association Française de Science Politique and the European Confederation of Political Science Associations. Didier Georgakakis is one of the six founding members of the European Alliance for Social Sciences and Humanities, which represents the SSH community at the European level.



**Prof. Miriam Hartlapp,**  
Freie Universität Berlin

**Miriam Hartlapp** is Professor for Comparative Politics: Germany and France at the Freie Universität Berlin (FUB) where she chairs three Franco-German dual degree programs that the FUB offers in cooperation with Sciences Po Paris and HEC Paris. Before joining the FUB in April 2017 she held chairs at Leipzig (2014-2017) and Bremen University (2013-2014) and worked at the Max Planck Institute for the Study of Societies in Cologne, the ILO in Geneva and the WZB Berlin Social Science Center. She has been visiting scholar i.a. at the EUI in Florence, Paris 1-Sorbonne and at the Université de Grenoble. Her research and teaching focus on European intergation and comparative politics, in particular questions of power, polarization and conflict in the EU Multilevel System as well as implementation and compliance. Currently she is academic coordinator of an Jean Monnet Network of Excellence on European Union Soft

Law Research (<https://www.solar-network.eu/home/>) and has been awarded an ANR-DFG project to research Effects of EU soft law across the multilevel system. She has been elected as Vice President of the German Political Science Association 2018-2021 (GPSA/ DVPW).



### **Prof. Stanisław Kistryn,**

Vice-rector for Research and structural funds  
Jagiellonian University in Kraków

Professor **Stanisław Kistryn** is a physicist with a specialism in nuclear physics, and a co-author of more than 180 scientific papers. He is currently President of the European Few-Body Research Committee, and Vice-rector for research and structural funds at Jagiellonian University in Kraków since 2012. He has participated in a number of committees and expert groups including the Committee for the Evaluation of Scientific Units, the Team for the Evaluation of Scientific Journals and the Group for Determining Algorithms of Financing Research Institutions, associated with Polish Ministry of Science and Higher Education. He has been designated as one of a few consultants on the new act on science and higher education. Since 2011 he has been concerned with evaluating research projects within NuPNET programme for Ministry of Science and Innovation of the Kingdom of Spain. Professor Kistryn is representing Jagiellonian University in international university networks – EUA, Coimbra Group, The Guild of European Research Intensive Universities (where he served as a first term Board Member / Treasurer), and in the newly established European University Alliance UNA EUROPA.



### **Prof. Antonino Rotolo,**

Vice-rector for Research  
Alma Mater Studiorum – Università di Bologna

**Antonino Rotolo** is a professor of philosophy of law and currently Vice-rector for research at the University of Bologna. He is an international expert in legal theory, legal logic, deontic logic, formal methods for practical reasoning, and theoretical artificial intelligence and law. In these areas, Antonino Rotolo has carried out research projects at international, European, and national levels.

He has been a visiting scholar at King's College London and at the University of Queensland and Queensland University of Technology (Australia). Antonino Rotolo has served as a board member or reviewer for several international journals and book series and as a chair of international conferences and workshops.



### **Prof. Alessandra Scagliarini,**

Vice-rector for International Relations

Alma Mater Studiorum – Università di Bologna

**Alessandra Scagliarini** is a professor of Infectious diseases and currently Vice-rector for International Relations at the University of Bologna. She is an international expert in veterinary virology with particular interest on epitheliotropic viruses infecting animals and humans, antivirals and innovative diagnostic tools. In these areas, Alessandra Scagliarini has carried out research projects at international, European, and national levels. She has been a visiting scholar at the Moredun Research Institute (Edinburgh, Scotland); Department of Microbiology, Otago University (Dunedin, New Zealand); Rega-Instituut, Virologie en Chemotherapie Unit (Leuven, Belgium); Department of Paraclinical Sciences University of Pretoria (South Africa). Alessandra Scagliarini served as a reviewer for several international journals and as a chair of international conferences and workshops.



### **Prof. Álvaro Torrente,**

Director of Instituto Complutense de Ciencias Musicales  
Universidad Complutense Madrid

**Álvaro Torrente** earned a degree in Musicology at the Universidad de Salamanca (1993) and obtained his PhD at the University of Cambridge (1997). After two years at Royal Holloway, University of London, he was appointed at the Universidad Complutense de Madrid (1999), where he is currently a Lecturer in Music History and Head of the Instituto Complutense de Ciencias Musicales. Between 2007-2017 he was Director-at-Large of the International Musicological Society. His research and publications focus on the sacred villancico and on Italian opera of the 17th and 18th centuries. He edited *La ópera en España e Hispanoamérica* (2001) with Emilio Casares, and *Devotional music in the Iberian World* (2007) with Tess Knighton, which received the

Stevenson Award of the American Musicological Society. He is Associate Editor of *The Operas of Francesco Cavalli* (Bärenreiter), and his editions of *La Calisto* and *L'Ercole Amante* and Cesti's *Orontea* have been performed in Munich, London, Amsterdam, Innsbruck, Basel and Frankfurt. His most recent book is called *La música en el siglo XVII* (2016). He has recently been awarded an Advanced Research Grant by the European Research Council to study "The Sources of Absolute Music: Mapping Emotions in Eighteenth-Century Italian Opera".



## **Prof. Jan Wouters,**

Jean Monnet Chair,  
KU Leuven University

**Jan Wouters** is Full Professor of International Law and International Organizations, Jean Monnet Chair ad personam EU and Global Governance. He is founding Director of the Institute for International Law and of the Leuven Centre for Global Governance Studies, an interdisciplinary research centre (with the status of both a Jean Monnet and KU Leuven Centre of Excellence) at KU Leuven. He is also President of KU Leuven's Council for International Policy. He studied law and philosophy at Antwerp University, obtained an LL.M. at Yale University and was Visiting Researcher at Harvard University. In his activities as Visiting Professor at Sciences Po (Paris), Luiss University (Rome) and the College of Europe (Bruges), he teaches EU external relations law, and as Adjunct Professor at Columbia University he teaches comparative EUUS perspectives on international human rights law. He is a Member of the Royal Academy of Belgium for Sciences and Arts and practises law as Of Counsel at Linklaters, Brussels. He is Editor of the *International Encyclopedia of Intergovernmental Organizations*, Deputy Director of the *Revue Belge de Droit International*, and an editorial board member in ten other international journals. He has published widely on international and EU law, international organizations, global governance and financial law, including 65 books, 130 journal articles and 200 chapters in international books.
